His brother Alvin and family, also the Julius Young family, have submitted their resignation from the Seminary and from the OLC, WITHOUT GIVING REASONS. Ken Barry has been received by the Wisconsin Synod and has a call. But I shall not believe that he will accept until I see his address in the "Northwestern Lutheran." He failed in Des Moines, he refused to go to Wheaton, and he withdrew from Trinity Church, after having submitted an apology for Pastor O.G. Schupmann. The matter seemed to have been ironed out, when he again started his Stänkerei. The sooner he gets out of this city, the better we shall like it.
